

Port Agents – handling conflicts between **Charterers &** Owners

- Gears/Equipment/Machinery breakdown
- Delay in vessel's schedule/loss of time
- Owners exercise lien on cargo
- Off hire matters/Laytime Documents for tramp services (Knowledge in difference types of Charter, Notice of Readiness, Statement of facts, Off hire/Laytime matters ... etc)

Port Agents – handling accident

- Crane/Cargo Gear mishap
- Damage to hull by tugs/barges
- Injuries to crew/stevedores
- Collision
- Fire
- Pollution
- Grounding
- Salvage/General Average

Charterers (Trading Firm)

- Marketing Dept conclude the sale contract
- Chartering Dept fix the required vessel
- Operations Dept handle the post-fixture



Ship Managers

Ship Managers (Full Management) Technical/Crew/Commercial Management



- Ensure vessels are built/maintained up to their standards
- Survey/Audit/Certification
- Supply (Store and Spare parts)
- Insurance/claims PNI & H/M (via insurance brokers)
- Accounting with Owners


SNP Brokers – New Buildings & 2nd hand vessels
